1 - Introduction

As part of the implementation of the *First Nations Land Management Act (FNLMA)* for the Lower Nicola First Nation Reserves, the Surveyor General Branch (SGB) has prepared a Land Description describing the extent of the Reserve lands as required under Section 6.1(a) of the Act for Logan's Indian Reserve No. 6.

Outstanding issues related to the jurisdictional boundaries of the Reserve or to the Land Description contained in this description are explained in Section 4.

The Land Description contained in Section 2 deals with the extent of the Reserve lands that will be subject to the Land Code of the Lower Nicola First Nation under the *First Nations Land Management Act* and is not intended to prejudice any of this First Nation's claims to lands.

The Land Description is based on a review of the Indian Lands Registry and other documents pertaining to the extent of title to the Reserve. The Land Description is not a legal interpretation of those documents. As there may be different legal interpretations of the documents, legal assistance may be required to determine the nature of the legal interests. The content of this Land Description is accurate based on the documents reviewed; however, there may be other documents that were not found or uncovered that may affect the extent of title to the Reserve.

This Land Description was prepared by Doug Bruce, CLS, of the Surveyor General Branch (SGB), per the Guidelines established under the authority of the Surveyor General of Canada.

The above described Reserve Lands are subject to:







4 - Additional Items

Logan's Indian Reserve No. 6 is surrounded by privately titled land owned by Douglas Lake Ranch and no apparent registered legal access exists to provide access to the Reserve. The First Nation may want to pursue obtaining an agreement granting legal access to the Reserve.
