seems like it was only yesterday that we were complaining of the cold temperatures and the unpredictable weather shifts in the valley. Now, we are fighting over the sun block as we deal with these extreme hot temperatures and the hot sun. I hope everyone is staying hydrated throughout each day. There has been information brought to my attention that some of our members have suffered from varied levels of heat stroke in the past week or so, so it is particularly important that we keep an

eye on the daily weather forecasts and be mindful to keep water and sunblock close by. It might even be a good idea to stay indoors for as much as is possible to avoid the heat and the sun. With the summer season comes much activity in our communities. Some of our members have gardens on the go

I attended the Assembly of First Nations annual general assembly earlier this month in Vancouver. It

was the first "in-person" engagement for the AFN since the covid-19 pandemic began in March of 2020.

I found the event to be especially useful in terms of reconnecting with respective Chief's from other

Nations. It was equally interesting to see what is happening at the national level with our National Chief

and the work that the AFN is doing on behalf of all Nations across Canada. There was unrest at the

national level as well of which I was not particularly aware.

Apparently, the Regional Chiefs of Canada

tried to have the national Chief temporarily suspended due to problems and conflict at the internal

operational level of the AFN. There was a sense of awkwardness and confusion at the Chief's level for

many Chiefs, including myself. Although the Regional Chief's proposed a motion to suspend the

National Chief pending an investigation, the Chief's and Proxies present defeated the motion and

demanded that the National Chief be reinstated and continue her duties as National Chief. National

Chief, Roseanne Archibald was very courageous in her stance and showed great leadership and strength.

I was very proud of how she managed the situation and I look forward to seeing how this issue unravels in the coming months.

LNIB Chief and Council made headway in our Custom Election Rules recently. An amendment was

proposed to include online voting to our voting process for this upcoming election. It was only days ago

that the amendment to include online/electronic voting to our voting process was passed at a special

meeting. I am extremely excited that this amendment was supported by our membership through a

voting process. In saying this, there have a few things that need to be dealt with for LNIB to be able to

use online voting. There are timelines that need to be adhered to with our Custom Election rules. For

LNIB to abide by these rules, LNIB Chief and Council made a

#### motion at our last Council meeting to

change the election day from October 2, 2022, to October 22, 2022. This change in date aligns and adheres to our Custom Election rules so that we are not breaching any elections rules. This eliminates any possible appeal that could develop as well. I want to thank all LNIB Electors that participated in this exercise, and I am very proud of this progressive shift in our voting processes. We should all be very proud of this amendment. I will say that there are other amendments we as a community need to consider in our Custom Election Rules and I hope the next leadership will take this into account in the next term.

Enclosing, I just want to say, please enjoy this beautiful summer! It has not been often that we can ease our minds a little bit due to the past few years. We have had to deal with so much over the past couple of years with fires, floods, our 215 and most recently, the Pope's visit to Canada. There is so much work that needs to be done in our communities. There is much healing that we need to endure as a people, and we need to continue this work for all. I am a proud member of LNIB, and I am even more proud to be your k<sup>w</sup>úk<sup>w</sup>pi?. I am honored and privileged and I thank all of you that have supported me. #### **Executive Director Report**

Dear LNIB Members,

I am pleased to present our monthly report for July 2022.

Here are some of the things we are working on:

Custom Election Rules: After many cancellations of the amendment process due to passings of members, the ratification vote occurred on Saturday July 23, 2022 at the Shulus Hall from 9:00am -8:00pm. The referendum to add online voting to the Custom Elections Rules passed with forty-six votes for and two votes against. At the July 26th Council Meeting, Chief and Council adopted a resolution to amend the Custom Election Rules.

Election 2022: Delays in the ratification vote to amend the Custom Election Rules, have impacted the dates for the Elections 2022 by delaying all processes by three weeks. The nominations meeting will now take place September 3, 2022. The advance polls will now be October 15, 2022 and Election day will be moved from October 1, 2022 to October 22, 2022. The Electoral Officer, informed LNIB that the General Election could not start until after the ratification vote to amend the Custom Election Rules was completed.

Human Resources: Band buildings are open to the public and Covid-19 safety protocols for staff and membership to follow if you wish. Feel free to ask the staff member you are visiting to use a mask and



to adhere to safety protocols if you are concerned. We are committed to keeping the community and employees safe during this pandemic.

#### Variation of Election Timelines

#### **WHEREAS**

- the Chief and Council of the Lower Nicola Indian Band ("LNIB") adopted Custom Election Rules in 1994 which were subsequently amended in 1998 and 2013 and are known as the Custom Election Rules of the Lower Nicola Indian Band (the "Custom Election Rules");
- LNIB is currently in the process of preparing amendments to the CER to allow for online voting (The "Amendments");
- 3. LNIB was provided with a draft version of the Amendments to the CER in February 2022;
- 4. LNIB scheduled a Special Information Meeting for April 2022 to review the Amendments with LNIB's membership, as required by CER section 33;
- the Special Information Meeting scheduled for April 2022 was postponed out of respect for the passing of an LNIB member;
- LNIB Chief and Council rescheduled the Special Information Meeting for June 23, 2022, to ensure adherence to the amendments process contemplated under the CER, and scheduled a community ratification vote to approve the Amendments for July 23, 2022;
- 7. at the Special Information Meeting on June 23, 2022, suggestions about the Amendments were received from LNIB membership, Chief and Council, and election service providers;
- 8. LNIB Chief and Council passed a Band Council Resolution to update the Amendments to include the suggestions received at the June 23 Special Information Session;
- LNIB Chief and Council scheduled a second Special Information Meeting for July 6, 2022 to review the updates to the Amendments;

- 10. no further comments were received from LNIB membership or Chief and Council on the updated Amendments at the Special Information Meeting held on July 6, 2022;
- 11. because of the postponement of the Special Information Meeting scheduled for April 2022, the timing of the Special Information Meetings in June and July 2022, and the long timelines associated with LNIB's electoral process, the community ratification vote to approve the Amendments scheduled for July 23, 2022 falls within the timeframe for LNIB's electoral process;
- 12. the beginning of LNIB's electoral process was scheduled to begin on July 14, 2022, for the upcoming election scheduled for the first Saturday in October 2022 (the "**Election**");
- 13. because of the ongoing process to review and ratify the Amendments to the CER, the Notice of Nomination Meeting required under the CER was not issued on the date specified by the CER;
- 14. proceeding with the electoral process for the Election without variation of the associated dates would result in non-adherence to the CER;
- 15. LNIB's Executive Director, the electoral officer appointed to conduct the Election, and legal counsel have advised LNIB's Chief and Council that, to preserve the integrity of the electoral process and ensure that the vote to ratify the Amendments to the CER is completed prior to beginning the electoral process, the date of the Election should be varied; and
- 16. Chief and Council consider varying the date of the Election to be in the best interests of LNIB, its membership, and the integrity of the electoral process.

#### NOW THEREFORE BE IT RESOLVED by Chief and Council of the LNIB that:

- 1. The date of the Election be varied so that the Election occurs on October 22, 2022;
- 2. LNIB's membership be notified of the variation of the date of the Election;
- LNIB staff and the electoral officer responsible for conducting the Election be authorized and directed to take whatever measures are reasonably necessary to give effect to the intent of these resolutions.

Motion #26-07-2022-06 Reads: The Lower Nicola Indian Band Chief and Council

Whereas: The First Nations Regional Health Survey (RHS) is a national First Nations-driven survey funded by the First Nations Information Governance Centre (FNIGC). The survey collects information from on-reserve and Northern First Nations communities based on both Indigenous and Western understandings of health and well-being. Since 1997, the RHS has been a reliable and valuable source of First Nations data for BC First Nations, First Nations organizations, and government departments and agencies for policy, planning, and renewal purposes;

Whereas: In BC, the First Nations Health Authority (FNHA) implements the RHS to collect data and information to inform health planning, investment, and transformation at the regional and provincial levels.

Whereas: In conducting and stewarding the RHS, the FNIGC and FNHA have an established infrastructure that maintains direct accountability to First Nations leadership, respect for First Nations' principles of OCAP®, while providing a security and privacy framework that meets the highest standards;

Whereas: Lower Nicola Indian Band Chief and Council acknowledges that, as part of the RHS process, children, youth and adults will be asked for their consent to participate in the survey. Participants under 14 years old will require their parent/legal guardian's consent. Participants have the right to decline answering any question(s). Data collection may be done online (preferred), over the telephone, on paper, or in-person. For in-person surveys, COVID-19 safety measures have been developed to keep

your community safe. All information provided is protected by privacy and security policies and procedures. Further, no individual community member will be identified in any report or publication resulting from this study and the data collected through this study;

Whereas: The FNIGC and FNHA will be bound by their contractual and consent commitments, together with the FNIGC Code of Research Ethics that state that there will be no release or dissemination of any data or information from the RHS that identifies or could lead to the identification of a community without authorization from that community's recognized leadership;

THEREFORE BE IT RESOLVED THAT: Recognizing the importance and value of data and information to inform planning and decision-making regionally, provincially, and nationally,

Lower Nicola Indian Band Chief and Council consents to the participation of Lower Nicola Indian Band First Nation in Phase 4 of the First Nation Regional Health Survey (RHS);

FURTHER BE IT RESOLVED that, pursuant to OCAP® principles, following the completion of the RHS, the Lower Nicola Indian Band First Nation will receive from the FNIGC/FNHA deidentified publically released reports and anonymous summary tables (e.g., tables of averages, rates, and frequencies) including data aggregated at the provincial and regional levels. FNHA's ability to return data in the form of summary tables at subregional and community levels is largely subject to data quality and privacy protection requirements. Communities will be grouped (by language family, Nation, or area) if there is sufficient participation to return subregional tables. Community participation is confidential, however reports that are representative of these communities in the subregional groupings will be returned. Subject to community participation rates being met, anonymous tables aggregated at the subregional, and regional tables, will be provided to Bridget LaBelle, Director of Human Resources, to be held on behalf of the community at the direction of Chief and Council.

FURTHER BE IT RESOLVED that if carefully approved by the FNHA and if appropriate privacy measures and agreements are in place, Lower Nicola Indian Band First Nation members' deidentified record-level (i.e., each participant's) data may also be used by authorized program developers, researchers, and First Nations-community-decision makers to assess and improve the health and well-being of First Nations, except in cases where an answer could reasonably identify members. Despite FNHA's commitment to OCAP®, FNHA cannot guarantee that de-identified record-level data can be shared with communities – this is subject to a community's capacity to protect the privacy of the data and FNHA's capacity to prepare de-identified data and enter into an Information Sharing Agreement with a community.

FURTHER BE IT RESOLVED that the Lower Nicola Indian Band First Nation acknowledges: a) The aggregate data reports and tables accepted by the First Nation, may have some results suppressed to protect the privacy of participants; and

b) If appropriate agreements and measures are in place, record-level data received by the First Nation will be de-identified, as required by individual respondents' consents; and

c) Community-level results may not be reported if it is not possible to survey a large enough sample size within each community to produce reliable community-specific statistics. The First Nation will be provided with reliable regional and provincial results; and

d) The First Nation agrees to have their community results grouped with other consenting communities in a subregional grouping, to qualify for subregional level results

FINALLY BE IT RESOLVED that the Lower Nicola Indian Band First Nation hereby agrees to grant temporary access to its local membership list for the purpose of sampling (selecting participants) for the RHS, on the condition that the band membership list shall not leave the band office, and only the names and contact information of the randomly selected participants and replacements will be required from the band membership list. The Band Membership clerk of the Lower Nicola Indian Band First Nation is hereby directed to assist the RHS sampling process.

Motion #26-07-2022-12 Reads: The Lower Nicola Indian Band Chief and Council move to approve the Ministry of Forests, Lands Natural Resource Operations & Rural Development Archaeological and Cultural Heritage Assessment and Referrals Contract FN23TEB091 in an amount not to exceed seventy-five thousand one hundred fifty dollars and zero cents (\$75,150) effective until March 31, 2025 and further authorizes the Executive Director to execute the agreement. Motion Carried

Motion #26-07-2022-13 Reads: The Lower Nicola Indian Band Chief and Council hereby authorizes the Executive Director to pay School District No. 58 Invoice number 2708 for the payment of two hundred one thousand four hundred eleven dollars and thirty cents (\$201,411.30) as per the annual 2021-2022 payment schedule of the Local Education Agreement. Therefore LNIB Council moves to direct LNIB staff and advisors to take the actions and expend the funds necessary to prepare the loan documents that would give effect to LNIB loaning \$2,500,000 in



respect of the Kingsvale Transmission Line Project, provided that this motion and any such loan documents are in compliance with all LNIB laws, including the LNIB Financial Administration Law. Motion Carried

- Consider providing pets and livestock with an alternate source of drinking water.

#### UNDERSTANDING WILLS & ESTATES

#### **On and Off Reserve**

The Indian Act estates sections apply to an estate if you are status (registered) First Nations person or entitled to be registered under the Indian Act and live on reserve; or live on reserve, but leave temporarily for educational reasons or seasonal employment; or leave the reserve for medical reasons or to go into a care facility. The estates sections do not apply if you are status (registered) or entitled to be registered First Nations person and live off reserve; are non status and live on reserve.

#### **Ordinarily Resident**

Under the Indian Act, Indigenous Services Canada (ISC) or Crown-Indigenous Relations and Northern Affairs Canada (CIRNAC) is only involved with estates for people "ordinarily resident" on a reserve. "Ordinarily resident" on a reserve means that an eligible First Nations person usually lives on a reserve and does not maintain a primary residence off a reserve. They may, however, temporarily live off a reserve for education purposes or to obtain care or services not available on a reserve.

When there is a will but no person is able to process the estate then Indigenous Services Canada will appoint someone from the BC Estates Unit to manage the account.

#### Reminder\* GATES & SECURITY CAMERAS

The Lands Department is responsible for the management and protection of all LNIB reserve lands. To prevent unlawful activity including dumping of hazardous materials and waste, as well as improper use of LNIB land, four gates were installed on Nicola Mameet IR1 in September of 2021.

#### SOLID WASTE MANAGEMENT PLAN

After many hours of hard work was done to cleanup various environmentally contaminated areas on LNIB land, multiple cameras and gates are now in place to protect reserve lands.

#### INSTALLATION OF CAMERAS

Security cameras are planned to be installed in Spring 2022 near significant areas and locations of interest. These cameras are for security purposes only and will not interfere with the privacy of neighboring homes, businesses, and communities. If you know of any areas of concern please contact us and we can see about getting a camera setup.

Members' use of the land will not be restricted by gates but may need to obtain access codes from the LNIB Lands Department. Contact the Lands team if you require access to use land that is behind a locked gate.

#### PARKING MANAGEMENT AGREEMENT

The Lands Department, with the support of Chief and Council, recently came to an agreement with Mario's towing to remove unwanted and abandoned vehicles from LNIB Reserve Lands. Many safety and environmental issues arise when vehicles are left in driveways, on the sides of roadways, and on culturally and traditionally significant areas of land. The Lands Department consulted Merritt RCMP prior to the floods in November 2021 to identify options available to LNIB to have these vehicles removed. The new Parking Management Agreement is intended to benefit all LNIB Reserve Lands and is part of the Solid Waste Management Plan that the Lands Department has been actively developing over the last two years.

# RAPID HOUSING INITIATIVE (RHI)



In October 2020 the Government of Canada, through CMHC, launched its Rapid Housing Initiative (RHI).

The initial funding was one billion to help address the urgent housing needs of vulnerable Canadians, especially in the context of COVID-19, through the rapid construction of affordable housing.

The first round of RHI exceeded its initial target if creating up to 3,000 new affordable units and will support the construction of more than 4,700 units across Canada. RHI Round 2 budget 2021 provides an additional investment of \$1.5 billion in new funding for the Rapid Housing Initiative in 2021-22 to address the urgent housing needs of vulnerable Canadians. The new funding will add a minimum of 4,500 new affordable units to Canada's housing supply. At least 25% of this funding will go towards women-focused housing projects.

# THE PROJECT

A 14 unit, two story, modular apartment building. This building will have 2 three-bedroom units, 4 two bedroom units and 8 one bedroom units. Our target demographic will be women, women and their children, as well as LNIB Elders.

All units will be rent-geared-to-income (RGI), so eligibility and income review will be done prior to moving in as well as annually and rent affordability will based on each individual household's income.

<u>Milestone</u> herbicide is considered minimally toxic to wildlife and is designated as a "reduced -risk" compound by the Pest Management Regulatory Agency (Health Canada).

Any projects that have the potential to disturb species at risk, migratory birds, waterways or could cause substantial environmental contamination must undergo an <u>Environmental Assessment</u> that either meets or exceeds the federal standard. Relevant Federal Standards are outlined in the Impact Assessment Act and Physical Activities Regulation.

**Invasive Weeds:** Invasive plant species are weeds that are not naturally occurring within the region they are found. These weeds are categorized as invasive due to the speed & amount in which they spread but also their ability to cause damage or negatively impact the natural environment, property, infrastructure, and rangelands. They are known to damage or destroy ecosystems by crowding out naturally occurring vegetation and making the environmental unusable for wildlife and humans alike.

They have the potential to impact safety, infrastructure, natural resource quality / quantity, recreation, wildlife habitat and agriculture.

These weeds spread continuously through many different sources and can destroy a natural habitat or your private property.



Invasive Dalmatian Toadflax 2022 – Nicola Mameet IR 1

**Identification:** Managing these noxious weeds in your own backyard starts with identification. A great resource to use when deciding if a plant in your yard is invasive is through the Thompson Nicola Regional District (TNRD) webpage:

This site shows all of the top listed regional invasive plant species around with pictures for reference. If you find a match for a species in your yard, you can then click on the picture to read some more information about the plant.

**Removal:** Wear Gloves! Many invasive weeds can cause rashes, have prickles or are toxic, so make sure to wear gloves when clearing them.

Check the TNRD website to find out the best methods for removing the invasive weed you may have identified in your yard.

# Always contain the weeds to a plastic bag or tightly secured within a tarp to make sure they are not spread to new locations on your property or elsewhere during transport!

This is a very important step because the spread of invasive weeds is one the greatest threats to natural biodiversity and occurs most often when plant fragments fall off vehicles and equipment as they move from one location to another.

**Disposal:** Get rid of all invasive weeds at the Eco Depot, separate all the invasive weeds from your general yard waste and ensure all the weeds are properly contained using a tarp or large plastic bag during transportation to avoid spreading the invasive weeds further.

**Disposal Location:** Take all contained invasive weeds to the Eco Depot, located at 2348 Woodward Rd, Lower Nicola, BC VOK 1Y0

**Re-Vegetate:** Seeding areas where soil has been disturbed or left bare will help prevent the establishment of invasive weeds in that area, <u>make sure to use native grass seeds or seed mixes</u> <u>that are certified to be free of new invasive weeds</u>. Re-seeding or re-vegetating areas where invasives have been removed from will help native plants populate in their place, reclaiming the natural environment.

The Daily Road: a Lifestyle of Restoration – Tony Broman

The reality of life can be very harsh for many people. My own life began the same way. We need to be comforted in our daily lives as we journey along. We face the uphill battles and hard seasons but along the way we have celebrations too. Growth, insight, hope all exist and can be found, embraced to ease the way for our steps.

We have heard what helps us many times: very important things, very powerful things.

- 1. Cultural identity,
- 2. Family and Community connection,
- 3. Health care, grief, substance use and trauma support.

These are very powerful but do not produce immediate relief for the feelings we wrestle with.

The good news because we aren't confused or missing any information. Struggles of this nature are very sad. Addiction, trauma, grief & loss often have common origins from sources that we do not choose personally. Along the way we wrestle with how to cope. How to take care of ourselves. How to keep going and improve our situation.

Most people address it one person at a time, one encounter at a time. For families it is daily life addressing it and it is a long journey with many ups and downs. It is learning to manage health together and as our own person so we don't get swallowed in another person's addiction. We learn to manage hope, expectations, persevere in love. And it is normal to break cycles and grow into health this way.

Here is my own story of this ...

My struggles with addiction started two generations back at least. The family history included all of the same elements: child abandonment, unwanted separation from parents, tragic loss of life, abuse and sexual abuse, trauma, jail time, substance addiction. It was passed down in a mixed bag with elements of health and unhealthy cycles, thinking, believing and acting. It came to me and I was too scared of it to choose the same path – too much hurt. I chose to believe differently – not because I was superior but because I was scared of their lifestyle and the pain it caused. So I looked for beliefs that gave hope and love and safety, and I found them. I did not escape trauma or abuse or grief but I was able to steer clear of substance misuse and narrowly escaped jail time. But many struggles continued for me – relationships were very challenging because of my fear and I could not trust in healthy ways. I was also bitter with rejection and disappointment, as well as very disempowered in my thinking and problemsolving. Growing in these areas and learning to be healthy happened through my own haphazard use of everything on this study's list – counseling, social programs, family, family of faith, community support and my own community and family involvement. It has been a journey of 50 years without a straight path – many circles back to certain issues, many stuck points of confusion or frustration, but also many celebrations and overall it is increasing in life and liberty.

I am not a model of health but I am grateful to have found a healthy path that continues to grow the garden of health and relationships I am longing for in this life. It is possible for us all but not always immediate or as widespread as our hearts long for. Faith, hope and love are required every day. Faith gives us strength to persevere as it holds fast to the end goal. Hope encourages our hearts to sustain us in the waiting, in the setbacks. Love overlooks many wrongs along the way and always draws alongside in support, not judgement as it is able to. Love is sacrificial and we will bear wounds along the way that we did not deserve as we step in to love, but love never fails.
