#### Message from the kwúkwpi? Stu Jackson

hen/le? Band members and community members. It is hard to believe, but our summer season has come to an end. It is guite surprising to see the leaves in the trees slowly change color as we move into the month of September. Although the summer season is closing, the temperature has not changed that much. We have been experiencing extreme heat these past few weeks and with heat comes the continued risk of forest fires. There have been many forest fires surrounding our Nicola Valley and fortunately, we have not had to deal with much fire hazard. Unlike our Shuswap and Okanagan neighbors, we have been very fortunate that fires have not impacted or affected our area. It is very important to understand that we must not become complacent, even during this time of year. I believe that we are still at high risk of fire danger so we must be diligent and do whatever is necessary to be fire safe, fire smart and fire ready. We cannot take anything for granted during these hot temperatures so let's be fire aware and prevent any fire risk. Fires can occur very quickly and suddenly so it would be very wise to be prepared at a moment's notice in case we become subjected to any fire danger. Council was in recess for the month of August, however, Council called a special meeting on August 19th Saturday at 10am. Many fires were in full activity during this time and we felt it was important to meet as a Council

to discuss and address any issues that LNIB may need to prepare for if any fire started in our area/territory. This meeting was convened so that we could speak proactively to any potential risks if a fire broke out. Thankfully nothing occurred in our territory, however, it was brought to our attention that some of our off-reserve band members were not so lucky. From what I understand, one our band members lost their home to fire. We also had some off-reserve band members evacuated from their homes in the Shuswap area. Chief and Council made a decision to assist any band members affected by fire/evacuation. If any of you know of any band members that have been evacuated from their homes due to fire, please contact the band office and provide any information you may have to help support these band members. Or contact the evacuated band members and have them contact the LNIB office. Although Council was in recess for the month of August, we did have a band meeting scheduled for August 28th. I was not able to attend the meeting in-person for personal matters and I tried continuous times to log into the meeting, unfortunately, I was unable to log into the meeting. I was able to get some feedback on how the meeting went afterwards and apparently there was a lot of challenging moments throughout the duration of the meeting. It was brought to my attention that the audio and video capabilities were quite marginal. People were having a difficult time hearing commentary in the meeting room as well as online. Council will look into these deficiencies and hopefully we will have these challenges addressed before our next band meeting in September. I want to apologize to the membership for this mishap and I want to assure each of you that it is Council's full intention to provide a good healthy and meaningful experience at all band meetings. I ask for your patience and understanding as we navigate through these growing pains of virtual engagement and upper scale technology. Let us hope that our September band meeting will be better and more effective whether you come in-person or chime in online.

Enclosing, I just want to wish all of you a happy end to the Summer season. I am sure many of you are sad to see summer leave, but there are many of you that are probably equally excited for the fall season. Hmm, let me guess. Hunting!!! Whatever the case may be, please lets all be safe in whatever it is we do as we delve into another month. Be cognizant of the hot weather and that fire risk is still amongst all of us. #### Dear LNIB Members,

I am pleased to present our monthly report for August 2023. LNIB continued to be busy on several initiatives. Here are some of the things we have been working on:

Wildfire Assistance: Chief and Council passed a motion on August 19, 2023 to approve assistance to membership who are evacuated from their primary residence due to the Wildfires. Thirty-eight members were called who were identified as located in Wildfire zones. Seven members and their dependents were provided with financial assistance. This assistance will continue for those who remain evacuated from their primary residence. Please reach out to LNIB if you are still under evacuation order on Monday, August 28, 2023.

Covid-19 Financial Aid: Chief and Council passed a motion on January 17, 2023 to do a final Covid-19 financial aid to all registered

band members in the amount of \$300.00. Forms are available to fill out at the Band Office you can also phone and request the form be filled out over the phone. As of May 25, 2023 there were 984 payments processed

out of 1,426. Leaving 442 members who have yet to apply and receive their payment. Encourage your family members to phone the band office for assistance in submitting their application. This is a benefit to on and off reserve members phone the band office if you require assistance filling out your form.

Upcoming Training and Workshops: LNIB will sponsor 8 sessions for members to attend driving lessons. Please contact Steve Wilks at Steve.Wilks@Inib.net if you have any questions. Commercial Training and Air Brake Endorsement for Class 1,2, 3, &4 are available. Please contact Sharon Parsons in Education at Sharon.Parsons@Inib.net to register. There are many more opportunities arising keep checking the website for updates.

First Nations Drinking Water Settlement: The Chief and Council passed a motion at the September 20, 2022 Council Meeting, to accept the Settlement Agreement of the individual class members who were residents on a Lower Nicola Indian Band reserve while a long-term drinking water advisory was in force on that reserve during the period applicable in the Settlement Agreement. In the meantime, please look at the following link, as there is some excellent information on this website: https://firstnationsdrinkingwater.ca/ The deadline to apply is extended to March 7,2024.

Human Resources: While visiting or receiving services at other buildings, please feel free to ask the staff member you are visiting to use a mask and to adhere to safety protocols if you are concerned. We are committed to keeping the community and employees safe during this pandemic.







# Entrepreneurial Considerations – Key Personality Traits – Local Opportunities

Recently, the number of businesses that LNIB members are considering has increased, more people are thinking about how they can develop their own ideas into a business. I want to use this month of the newsletter to communicate some key elements of how one can go about this journey, the personality traits one should seek to maximize and finally some ideas one could consider.

#### Things to consider when starting a business

These are the top three things to consider when thinking about starting a business and an entrepreneurial journey.

#### 1. Why am I doing this? If you can't answer this, you're not ready

There are many reasons why one would consider starting a business including money, freedom and the opportunity to bet on yourself. Each person willing to walk this path will have their own why, but from what I have seen, the main" Why" should have the following element that is unshakeable. This element is the unbreakable will to solve a problem and make people happy. If you incorporate this angle into your why, the money, freedom and overall benefits of the journey will become evident. As much as you are the main character in your own adventure, the real plot is being a hero for a customer with a problem.

#### 2. If you have a why, you need a plan!

Not only is your business plan a tool for planning and applying for financing, but it is also an initial test to see if your idea can make the jump from idea to reality. When you go through the motions of creating a business plan, writing it, revising it, the gravity of the situation becomes clear. You will have a clear understanding of what is required of you to get to Day 1 and the launch your venture. By putting significant time into your plan, you will have a clear picture of the operational, regulatory, marketing, sales and financial implications of your idea and it will be the last step before you take the jump.

#### 3. The power failing forwards.

Winning is great but it's temporary, to grow you need to learn and to learn you need to fail. To fail-forward is how you generate momentum to keep going, while you're learning and putting your idea's out there to be validated by the only test that matters at the end of the day, which is: did the customer buy the product or service, and will they come back?

This mindset will allow you to grow and learn by example and the no's and failures become something that loses its negative connotation as they become tools to guide you back onto the path of success. If you commit to failing forwards, you may lose a battle, but you gain a footing in the war.

#### **Personality Traits**

#### Grit

This trait is one of the most important because it determines your ability to get hit and keep going. Not everything is going to go according to plan and there will be setbacks. If you have grit, you will be able to power through anything that comes your way.

#### Creativity

Creativity can take many shapes and forms and it will be called upon to deal with many of the facets of being in business. Not only will you need to employ with in marketing and product creation, but you will have to use it for basically any situation you deal with. If you can tap into your creativity in any way, your journey gets more interesting.

#### Stick-to-itiveness

In other terms, this trait is your ability to be sticky, to have follow through and see something through to completion. It's an important trait to develop and hone because you will quickly learn you will have things pile up; you can't deal with everything at once if you have a schedule. By being sticky to your tasks and goals you make sure things don't slip through the cracks.

#### **Business Idea's for Full Time or Part Time Ventures:**

#### Full Time

**Cleaning Service:** A cleaning service can be used for residential, commercial or industrial clients. It is a great way to secure contracts and generate recurring revenue.

**Coffee Stand:** Everyone drinks coffee, and it has a high profit margin. If you are able to secure a space, a trailer or way to set up a coffee stand that sold small baked goods, you can give yourself a full-time opportunity.

**Delivery/Hauling Business:** If you have a truck or large van and don't mind driving, there are many ways to get into business delivering and hauling goods. You could start with small things like groceries and pharmacy items as well as doing junk removal and dump runs.

**Bookkeeping:** For a small investment that is often covered by grants, you could get educated and get into business as a bookkeeper for small businesses and contract to accounting firms. The cost of a bookkeeping certificate is around \$1,500.

**Applicance Repair:** Every house has multiple appliances, and the number of appliance repair professionals has been declining. No formal education is required to obtain the red seal certification; however, you can take a foundational program that will credit you 825 hours of the 7200 required by the training authority. Currently, there are only 2 appliance repair companies in Merritt and this number could decrease as the owners may be considering retirement in the near future. This would leave over 10,000 people to be serviced by 1 appliance repair person.

**Locksmith:** Every building, home, business has locks. There is only one locksmith business in town, and this would provide a great opportunity to look for a career change that has potential future prospects. To become a certified locksmith, you need 3600 hours of work-based training. No formal education is required, and you can become fully certified in about 2 years.

#### Part Time

**Tour Guide:** Start your own tour guiding business and conduct your tours when you have the time available. You could look at doing hikes, paddleboard tours and more.

**Custom Maker:** You can make anything you really want to and slap a price tag on it. It could be clothing, furniture, art or anything your imagination can create. This is more suited as a part time venture due to the fact that people find these to be passion-based businesses and when the need to produce outweighs the passion, it loses it's spark.

**Pet Business:** You can start a dog walking, pet day care or pet grooming business and any of them could grow to become full time ventures. No formal training or certification is required but you should be good with animals and love to be around them if you want to pursue this option.

**Freelancer:** You basically freelance anything, many people choose to be freelance photographers, videographers, writers, artists and actors. If you have a passion and feel like you can monetize it, why not try?

#### PROJECT UPDATE: SECURITY CAMERAS AND GATES

The Lands Department is responsible for the management and protection of all LNIB reserve lands. To prevent unlawful activity including dumping of hazardous materials and waste, as well as improper use of LNIB land, four gates were installed across Nicola Mameet IR1 in September of 2021.

#### **SOLID WASTE MANAGEMENT**

After hours of hard work was done to cleanup various environmentally

contaminated areas on LNIB land, multiple gates were put in place to protect reserve lands.

#### CAMERAS

Security cameras were recently installed near important areas on reserve. Cameras are intended for security purposes only and will not interfere with the privacy of neighboring homes, businesses, and communities. The use of trail cameras is the best strategy for sites where it would not be appropriate to restrict access by installing a gate. Members' access to reserve lands will not be restricted by gates though some areas may require gate codes. Contact the Lands Department during regular office hours to obtain a code.

### **NOTICE TO COMMUNITY MEMBERS ON WILDLIFE SAFETY**

#### Please refrain from leaving hunting remains, animals' entrails or trimmings up Mamit Lake Branch Road or anywhere near the community / residential areas.

Animal remains attract predators, leaving remains from a hunting trip too close to the community habituates the predators to keep returning for more food. Predators such as coyotes, bears and wolves will keep returning where there is food available to them. Attracting additional predators into the community will create an unsafe environment for children, pets, and all members of the community. Please relocate hunting remains or animal innards outside of the community by leaving them far away from residences or known industry. An alternative to Mamit Lake Branch Road could be up highway 97C, past the industrial park.

#### **LNIB Ticketing and Enforcement Law**

#### Why We Need Laws

Laws are rules made by the government that forbid certain actions and are enforced by the courts. Laws apply to everyone equally. If you break a law, you may have to pay a fine, pay for the damage you have done, or go to jail.

Imagine the chaos – and the danger – if there were no laws. The strongest people would be in control and people would live in fear. Drivers could choose which side of the street to drive on and no one could stop them. Imagine trying to buy and sell goods if no one had to keep promises. Or trying to hold onto your personal property or even to keep yourself safe if there were no laws against robbery or assault.

Even in a well-ordered society, people disagree, and conflicts arise. The law provides a way to resolve disputes peacefully. If two people claim the same piece of property, rather than fight they turn to the law. The courts can decide who the real owner is and how to protect the owner's rights.

Laws help to ensure a safe and peaceful society. The Canadian legal system respects individual rights and ensures that our society is orderly. It applies the same law to everybody. This includes the police, governments and public officials. All of them must carry out their duties according to the law.

#### LNIB Ticketing and Enforcement Law

Given the inherent right of LNIB to self-government and stewardship of our lands, and as enabled by the *Land Code*, the Lands Department will recommend that the Chief and Council ratify *LNIB Ticketing and Enforcement Law*. The Law was tabled at a duly convened meeting of Chief and Council on **August** 1<sup>st</sup>, 2023 and will be considered for ratification at a duly convened meeting of Chief and Council on **September 19<sup>th</sup>**, 2023 or a later meeting if required. A Public Hearing for final review of the law by the members is rescheduled for **September 14<sup>th</sup>**, 2023.

The purpose of the *Ticketing and Enforcement Law* is to enable the fair, effective, and efficient enforcement of all LNIB laws. Enacting an overarching *Ticketing and Enforcement Law* rather than enforcement provisions in each individual law makes sense at this time because of the robust suite of laws that LNIB is developing. This approach allows LNIB to avoid repetition, and possibly confusion, by repeating the same enforcement provisions in different laws. LNIB staff, members, residents and others interested in or affected by our laws must look only to one location for enforcement provisions.

The *Ticketing and Enforcement Law* enables Council to appoint a Justices of the Peace or an Adjudicator, sets out their authorities, and the circumstances under which they must refer matters to a Judge. The law designates Enforcement Officers and sets out their authorities also.

The *Ticketing and Enforcement Law* establishes the requirements for tickets including their form and content, the serving of tickets, payment of fines or disputing tickets, and the process for hearings of disputes. The law lays out a process for instances when a person fails to appear at a hearing or fails to respond to a ticket, including time extensions in certain circumstances and collections.


Schedules to the law list all LNIB laws to which the *Ticketing and Enforcement Law* applies, and establishes the applicable fines and penalties for offences.

#### Thompson Nicola Regional District Mosquito Surveillance and Control Program

#### 01 – 31 July 2023 Progress Report

Overall weather conditions for the Merritt, Nicola and Douglas Lake areas during July 2023 were "drier" than normal and it was the seventh month in a row when precipitation totals were at, or below the 5 year (2018-2022) normal. Total precipitation for July 2023 (5.8mm) was just 35% of normal for the month.



Because of drier winter and spring conditions, and the below average snowmelt, Douglas Lake and Coldwater River levels were moderate and there was no flooding into June or July 2023. Nicola Lake levels were managed/maintained at just below the flood/larval development threshold of 3.2m for the entirety of the summer. As a result, Nicola River levels were also well below the flood/larval development threshold during June and July. Larval development, where it was observed during July 2023 was in permanent ponds and slow draining river oxbows, seepage areas or spring-fed habitats.

Regular sampling throughout the month of July found recurring larval development in a total of 29 different sites. Recurrent larval development was observed at several sites in the Douglas Lake, Quilchena (Nicola Lake) and Lower Nicola areas. Several permanent ponds (Sites DL05b, DL13, DL14, DL16, DL18, DL20, DL21) located in farm fields around Douglas Cattle Ranch were active on 1-3 occasions during July. Several slow-draining and permanent sites (Qu01, Qu02a,c, Qu04, Qu07,Qu08,Qu09, Qu10A, Qu10B) located in the old golf course and adjacent farm fields in Quilchena/Nicola Lake area were also repeatedly active with larval development during July.



Several sites in the Lower Nicola floodplain, mostly permanent ponds and Typha sp. (cattail) swamps were also active with developing larvae on 1-2 occasions during July. Larval populations were highly variable and ranged from 1-30 larvae/dip sample with most sites averaging 3-10 larvae/dip sample.

A total of 230 inspections were completed at 69 individual sites. A total of 57 treatments were completed from the ground to control developing larval populations at 29 different, and active, sites. A total of 43.70 kg of VectoBac 200G were applied from the ground to 5.83 ha of habitat.



The figure below presents the July 2023 Operational Summary for the area.

Larval and adult sampling and collection by Duka Ltd. personnel will continue through till mid-August when field operations will start winding down. Larvicide (VectoBac 200G) treatments will be completed as required, and where necessary to control developing larval mosquito populations.







# **HOUSING ANNOUNCEMENT**

#### SEPTIC SYSTEM MAINTENANCE

Your septic system is a living ecosystem, and you need to do your part to ensure it is healthy and working as it should.

Never put anything down the drain or toilet that will not biodegrade, including but not limited to, wipes (Lysol, baby, etc.), clothes, bottles, feminism products, paper towel, plastic, etc.

Don't use chemicals like bleach as it kills the good bacteria that breakdown the solid waste.


Space out your water consumption so the tank and drain field are not overwhelmed. By this we mean don't do excessive loads of laundry in a day, have extended showers, leave your tap running unnecessarily, etc.

The drain field (or leach field) is the area on your property where wastewater from your septic system is dispersed into the soil. To avoid damaging the drain field and overall functioning of the septic system; - Never park a vehicle, build a structure, have large livestock animals, have fires, or plant trees or a garden over your septic system's drain field - You should also prevent excess water from flowing over your drain field by making sure your downspouts are pointing away from it because a saturated field cannot drain and process wastewater.

These are some of the simple steps that can save time and money and extend the life of your septic system.

- Attend Chief & Council Meetings as requested.



## **Jumbo Raisin Cookies**

#### Ingredients

- 2 cups raisins
- 1 cup water

3<sup>1</sup>/<sub>2</sub> cups all-purpose flour

- 1 teaspoon baking powder
- 1 teaspoon baking soda
- 1 teaspoon salt

Place water and raisins in a small saucepan, and bring to boil. Boil 3 to 4 minutes. Set aside to cool.

Preheat oven to 375 degrees F (190 degrees C). Grease cookie sheets.

<sup>1</sup>/<sub>2</sub> teaspoon ground cinnamon Combine flour, baking powder, <sup>1</sup>/<sub>2</sub> teaspoon ground nutmeg baking soda, salt, cinnamon, and

- 1 cup shortening
- 1<sup>3</sup>/<sub>4</sub> cups white sugar
- 2 eggs

1 teaspoon vanilla extract 1/2 cup chopped walnuts



nutmeg; set aside.

In a large bowl, cream together shortening and sugar. Beat in eggs and vanilla. Stir in raisins along with the liquid in which they were boiled. Blend in flour mixture, then mix in the walnuts. Drop by tablespoonfuls onto the prepared cookie sheets.

Bake for 12 to 15 minutes in preheated oven, or until firm. Remove from cookie sheets to cool on wire racks.
