henle? band members and community members. First and foremost, I want to wish each of you a very Merry Christmas and Happy New Year!! December is always the busiest month of the year for many of us, so I hope that we are all being safe in our travels and our activities. Chief and Council have continued to meet regularly this month and have conducted the necessary business at our duly convened meetings. There are a number of opportunities on the horizon for LNIB and it is exciting to know that Council is on board with moving forward with some of these initiatives. Chief and Council have agreed to move ahead on pursuing a possible stake and/or purchase of the Trans Mountain Pipeline Expansion Project. After some good discussion at our recent Council meeting, Council agreed to put further effort and investigation into this endeavor. A working group will be established in the very near future and a report will be completed and presented to Chief and Council and membership to determine whether or not LNIB should pursue a stake and/or purchase in this project. This is a very exciting step for LNIB and I am looking forward to the results of this report.

LNIB is also engaging in an opportunity to participate in the Aspen and Highland Solar Projects. LNIB has been collaborating with Canadian Solar since early 2021 to develop these projects and all parties have conducted extensive technical, financial and environmental assessments of both projects. It has been identified and determined that LNIB could benefit significantly with ongoing revenue, employment and training benefits and contracting benefits for LNIB owned and member owned businesses. This is another exciting opportunity for LNIB and we will continue with our due diligence to move forward with this file. We will have Canadian Solar attend our band meeting in January to provide a presentation to membership. This is just a snap shot of some of the things Chief and Council deal with when we meet. Chief and Council will recess for the remainder of December and we will reconvene on January 2nd 2024.

Once again, I want to wish all of you a very happy holiday season. I don't want to forget our people that may be struggling out there as well. Christmas is supposed to be a happy time for everyone, but the reality is that it isn't a happy time for some. Please keep in mind during this festive season that not everyone is in a good place. Dear LNIB Members,

I am pleased to present our monthly report for December 2023. LNIB continued to be busy on several initiatives. Here are some of the things we have been working on:

Christmas Financial Aid: There were three different payments made out to assist this Christmas season. One payment of \$100/household according by mailing address to the eldest person in the household. This is to assist with the family Christmas meal, however, feel free to spend where required. There were 733 payments issued via direct deposit and cheque. The second payment made was to parents/guardians for minor children in the amount of \$50.00 for each registered minor child. There were 139 payments made. The third payment was for Elders aged 60 years and up in the amount of \$50.00. There were 246 payments made to Elders. Merry Christmas and Happy New Year. Remember to submit your direct deposit information in the future to expediate your payments from LNIB.

Covid-19 Financial Aid: Chief and Council passed a motion on January 17, 2023 to do a final Covid-19 financial aid to all registered band members in the amount of \$300.00. Forms are available to fill out at the Band Office or you can also phone and request the form be filled out over the phone. As of May 25, 2023 there were 984 payments processed out of 1,426. Leaving 442 members who have yet to apply

and receive their payment. Encourage your family members to phone the band office for assistance in submitting their application. This is a benefit to on and off reserve members, phone the band office if you require assistance filling out your form. There was some confusion that there was an additional payment, this is a continuation of the payment made at the beginning of the year. If you have not received this payment yet in 2023 you can still apply for this payment.

First Nations Drinking Water Settlement: The Chief and Council passed a motion at the September 20, 2022 Council Meeting, to accept the Settlement Agreement of the individual class members who were residents on a Lower Nicola Indian Band reserve while a long-term drinking water advisory was in force on that reserve during the period applicable in the Settlement Agreement.

In the meantime, please look at the following link, as there is some excellent information on this website: https://firstnationsdrinkingwater.ca/ The deadline to apply is extended to March 7,2024.

Human Resources: While visiting or receiving services at other buildings, please feel free to ask the staff member you are visiting to use a mask and to adhere to safety protocols if you are concerned. We are committed to keeping the community and employees safe during this pandemic.

We'd also like to welcome the new members to our team at LNIB: Uska Beatty-Smith, Field Crew Lead, Chris Grund, Power Tech Assistant, Daycia Stephens, Homemaker, Mac Jedrzejczyk, Biologist Manager, Megan Beckett, Janitor and Derek Nelson, On-Call Cook.

WHEREAS notwithstanding the default Residence Rights of such persons, section 24.1 of the Land Code further allows the Lower Nicola Indian Band Chief and Council ("Council") to alter or revoke such rights by band council resolution;

WHEREAS section 24.4 of the Land Code provides that any person who resides or remains on the Lands without a Residence Right is guilty of an offence, and may be evicted, removed or made subject to other consequences;

WHEREAS Barb Caldwell, who is not a member of the Lower Nicola Indian Band, has resided in a RV travel trailer on Lot 326, Nicola Mameet Indian Reserve #1 of the Lands approximately since at least October 5, 2023, and possibly earlier;

WHEREAS on September 20, 2022, Council passed a resolution which reads: "The Lower Nicola Indian Band Chief and Council hereby prohibits RV's to be utilized as dwellings, residences, or cabins on LNIB Lands including CP Lands and Custom Family Lands unless they receive prior written authorization by the Lands Manager";

WHEREAS Barb Caldwell never sought or received prior written authorization from the lands manager to reside on Lot 326, Nicola Mameet Indian Reserve #1 in a RV travel trailer;

WHEREAS Council is of the view that Barb Caldwell does not fall within the scope of persons who have a Residence Right under section 24.1 of the Land Code and hence he is guilty of an offence under section 24.4 of the Land Code;

WHEREAS in the alternative, if Barb Caldwell does have a Residence Right by virtue of his being an "invitee" of a member interest holder, then Council is of the view that it is in the best interest of the Lower Nicola Indian Band to revoke that Residence Right;

WHEREAS in either event, whether or not Barb Caldwell has a Residence Right, Council is of the view that it in the best interest of the Lower Nicola Indian Band to take steps to discontinue Barb Caldwell's residential occupation on the Lands.

WHEREAS the Council passed the following resolution with Resolution # 11-14-2023-06 on November 14, 2023:

NOW THEREFORE BE IT RESOLVED AS FOLLOWS:

- 1. Any Residence Right that Barb Caldwell may have pursuant to Land Code is hereby revoked in accordance with subsection 24.1 of the Land Code (the "Decision");
- 2. Notice of the Decision will be provided to Barb Caldwell as soon as practicable (the "Notice");
- 3. Barb Caldwell will be provided with an opportunity to appeal the Decision to Council, within 14 days of the date upon which the Notice is served (the "Appeal Period");
- 4. If Barb Caldwell does not appeal the Decision, or vacate the Land, during the Appeal Period, Barb Caldwell will be deemed guilty of an offence under the Land Code, and the Lower Nicola Indian Band will take steps to prosecute such offence.
- 5. If Barb Caldwell appeals within the Appeal Period, then Council will reconsider the Decision and, within two weeks of the submission of the appeal, make a determination to either affirm, alter or quash the Decision (the "Appeal Determination"); and
- 6. If the Appeal Determination affirms the Decision, then:
 - a. Barb Caldwell will be deemed guilty of an offence under the Land Code; and
- b. the Lower Nicola Indian Band will take steps to prosecute such offence.

WHEREAS the Notice of the Decision was delivered to Barb Caldwell on November 15, 2023, and this began the 14-day Appeal Period set to expire on November 29, 2023;

WHEREAS Barb Caldwell did not appeal the Decision, or vacate the Land during the Appeal Period;

AND WHEREAS Barb Caldwell emailed a letter (the "Appeal Letter") on behalf of both Barb Caldwell and Mike Pockrant to the Director of Lands and Housing on November 30, 2023, addressed to the

- Articulates this support to the government of Canada and other external interests Motion Carried

Motion #12-19-2023-06 Reads: The Lower Nicola Indian Band Chief and Council WHEREAS the Lower Nicola Indian Band operates under the authority of Chief and Council. WHEREAS the Government of Canada owns and operates the Trans Mountain Pipeline and the Trans Mountain Expansion Project (collectively referred to as "Trans Mountain Pipeline System" or "TMPS"). WHEREAS the Government of Canada intends to sell all or a portion of the Trans Mountain Pipeline System to Indigenous communities located on or near the TMPS right of way.

WHEREAS several Indigenous ownership ventures, representing Indigenous communities located along the TMPS right of way, have emerged as potential purchasers of the ownership interest in TMPS ("Indigenous Ownership Groups").

WHEREAS Chief and Council have engaged in preliminary discussions with the Government of Canada and with certain Indigenous Ownership Groups, and Chief and Council have determined that the purchase of an ownership share in the TMPS by the Lower Nicola Band may provide LNIB with significant ongoing revenue and enable LNIB to gain greater control over its lands and territories and enhance LNIB's ability to protect its natural resources.

WHEREAS the Lower Nicola Indian Band needs to conduct further due diligence in order to fully assess the potential risks and benefits of purchasing an ownership interest in the Trans Mountain Pipeline System, including an assessment of potential revenues, financing risk, liability risks, and reputational risk.

THEREFORE BE IT RESOLVED THAT:

- 1. Lower Nicola Indian Band Chief and Council support, in principle, the potential purchase of an ownership share in the Trans Mountain Pipeline System by the Lower Nicola Indian Band.
- 2. LNIB staff, members of Chief and Council, and LNIB's professional advisors ("Due Diligence Group") immediately conduct further due diligence in order to:
 - a. fully assess the potential risks and benefits of purchasing an ownership interest in the Trans Mountain Pipeline System; and
 - b. in the event that it is determined that LNIB should seek to purchase an ownership interest, assess whether LNIB should negotiate directly with the Government of Canada, or whether LNIB should join with one of the Indigenous Ownership Groups, and if so, which Indigenous Ownership Group the LNIB should join.
- 3. The Due Diligence Group provide Chief and Council with a report summarizing their conclusions regarding the items outlined in paragraph 2 above, as soon as reasonably possible.
- 4. Any member of Council is hereby authorized and approved to do all such further acts, engage in all such communication, and prepare, deliver and execute all other documents as may be required in order to give effect to this Band Council Resolution.

Motion #12-19-2023-07 Reads: The Lower Nicola Indian Band Chief and Council WHEREAS the Lower Nicola Indian Band operates under the authority of Chief and Council. WHEREAS Canadian Solar Solutions Inc. ("Canadian Solar") and Recurrent Energy ("Recurrent") propose to develop two utility-scale solar energy and storage projects in LNIB traditional territory, known as the Aspen Solar Project ("Aspen") and the Highland Solar Project ("Highland"). WHEREAS LNIB has been working collaboratively with Canadian Solar and Recurrent since early 2021 to develop the Aspen and Highland Projects, and the parties have conducted extensive technical, financial, and environmental assessments of the Projects.

WHEREAS LNIB and Canadian Solar and Recurrent have developed an Impact Benefit Agreement and Project Agreements which set out the proposed commercial terms of LNIB's participation in and support of the Aspen and Highland Projects, which provide for, among other things, LNIB acquiring an ownership interest in the Projects, the payment of royalties and other amounts to LNIB, and LNIB's support of and assistance in developing the Projects ("LNIB Participation").

WHEREAS Chief and Council have determined that LNIB Participation in the Projects may provide LNIB with significant ongoing revenue, employment and training benefits, and contracting benefits for LNIB-owned and member-owned businesses.

WHEREAS LNIB's Referrals Department has completed traditional land use and environmental studies of the Projects, and has concluded that the Projects do not create any cultural, heritage, or environmental concerns however, Council recognizes that these projects do create some cultural, heritage and environmental concerns.

THEREFORE BE IT RESOLVED THAT:

- 1. Lower Nicola Indian Band Chief and Council strongly supports the potential LNIB Participation in the Aspen and Highland Projects.
- 2. LNIB staff, members of Chief and Council, and LNIB's professional advisors, working in collaboration with Canadian Solar and Recurrent, shall:
 - a. complete, as soon as reasonably possible, LNIB due diligence regarding LNIB Participation in the Aspen and Highland Projects;
 - b. negotiate and seek to finalize the binding versions of the Impact and Benefit Agreement and Project Agreements; and
 - c. regularly report back to Chief and Council regarding progress on items a and b above.
- 3. Any member of Council is hereby authorized and approved to do all such further acts, engage in all such communication, and prepare, deliver and execute all other documents as may be required in order to give effect to this Band Council Resolution.

PROJECT UPDATE: SECURITY CAMERAS AND GATES

The Lands Department is responsible for the management and protection of all LNIB reserve lands. To prevent unlawful activity including dumping of hazardous materials and waste, as well as improper use of LNIB land, four gates were installed across Nicola Mameet IR1 in September of 2021.

SOLID WASTE MANAGEMENT

After hours of hard work was done to cleanup various environmentally contaminated areas on LNIB land, multiple gates were put in place to protect reserve lands.

CAMERAS

Security cameras were recently installed near important areas on reserve. Cameras are intended for security purposes only and will not interfere with the privacy of neighboring homes, businesses, and communities. The use of trail cameras is the best strategy for sites where it would not be appropriate to restrict access by installing a gate.

Members' access to reserve lands will not be restricted by gates though some areas may require gate codes. **Contact the Lands** Department during regular office hours to obtain a code.

DRAFT TRESPASS LAW OVERVIEW

PURPOSE

The purpose of this Law is to provide for the protection, management, use and possession of LNIB Land by:

- a. regulating the residence and access of individuals invited on LNIB Land; and
- b. prohibiting trespassers on LNIB Land.

ROLES AND DUTIES

KEY TERMS IN THE LAW

"Interest" means an interest in LNIB Land, and includes an Allotment (or CP), Leasehold, and Easement, but for greater certainty does not include title to the land.

"Licence" means a licence, permit or other permission granted under this Land Code, or a licence or permit issued pursuant to the *Indian Act* prior to the effective date of this Land Code, to use, develop, or extract specified Natural Resources from, or otherwise have non-exclusive use of, LNIB Land but which does not grant an Interest in, or possession to, LNIB Land.

"Invited Guest" means a person authorized to:

- a. reside on LNIB Land because they have been invited to do so by an Inviter in accordance with paragraph 24.1(d) [Right of Tenancy] of the Land Code; or
- b. access LNIB Land because they have been invited to do so by an Inviter in accordance with paragraph 24.2(c) [Right of Access] of the Land Code.

"Inviter" means:

a. the following persons who are authorized to invite another person to reside on LNIB Lands:

- i. a Member who has been allocated a residential lot by Council under paragraph 24.1(a) [Right of Tenancy] of the Land Code; and
- ii. a Member with an Interest in LNIB Land, in accordance with paragraph 24.1(c) [Right of Tenancy] of the Land Code; and
- b. a holder of an Interest or a Licence in LNIB Lands who is authorized to invite another person to access LNIB Lands, in accordance with paragraph 24.2(a), (b) and (c) [Right of Access] of the Land Code;

PROHIBITION ORDER

If Council has reasonable grounds to believe that an Invited Guest poses a threat or may cause harm to the LNIB community or LNIB Land then Council may, by Band Council Resolution, revoke that right by issuing a Prohibition Order that prohibits the Invited Guest from residing on LNIB Lands, from accessing LNIB Lands, or both. The Order must be delivered to the individuals affected within 5 days and will be posted in public places. Individuals affected by the order can dispute it in writing.

TRESPASS PROHIBITED

A Person who does any of the following, without lawful authority or permission, commits an offence:

- a. enters onto or occupies a Premises if entry onto or occupation of the Premises is prohibited;
- b. enters onto, occupies or does not immediately leave a Premises after a Notice of Trespass, setting out that the Person's entry onto or occupation of the Premises is prohibited; or
- c. engages in or does not immediately stop an activity on or in a Premises, after being given a Notice of Trespass setting out that the activity they are or were engaging in is prohibited on or in the Premises.

NOTICE OF TRESPASS

Notice of Trespass may be given in one or more of the following ways:

- a. orally or in writing;
- b. by means of a sign or signs which are posted so that the signs:
 - i. are clearly visible;
 - ii. contain writing that is clearly legible, if any writing is used, to indicate a prohibition; and
 - iii. contain graphic representations that are clearly visible, if any graphic representation is used, to indicate a prohibition; or
- c. by Band Council Resolution posted in a public area and available at the LNIB administrative offices.

RATIFICATION

The Lands Department is planning to schedule community engagement meetings regarding the draft Trespass Law in January 2024 and the Chief and Council may consider ratifying the Law in February 2024. NOTICE TO COMMUNITY MEMBERS ON WILDLIFE SAFETY

Please refrain from leaving hunting remains, animals' entrails or trimmings up Mamit Lake Branch Road or anywhere near the community / residential areas.

Animal remains attract predators, leaving remains from a hunting trip too close to the community habituates the predators to keep returning for more food. Predators such as coyotes, bears and wolves will keep returning where there is food available to them. Attracting additional predators into the community will create an unsafe environment for children, pets, and all members of the community. Please relocate hunting remains or animal innards outside of the community by leaving them far away from residences or known industry. An alternative to Mamit Lake Branch Road could be up highway 97C, past the industrial park.

MONTHLY INVASIVE WEED SPOTLIGHT: FIELD BINDWEED





Description: Field Bindweed is a perennial vine with trumpet shaped white / pink flowers sprouting from a creeping vine. This invasive is easily recognizable since it closely resembles a smaller version of the common morning glory and is closely related to hedge bindweed as well. This invasive weed spreads via seed dispersal, creeping root systems, rhizomes and even the fragments of vine stems. Bindweed seeds can remain viable / dormant for up to 30 years before sprouting, spread through birds, washed down waterways or via equipment, clothing and vehicles. Root systems can be up to 5-10m deep in the ground and up to 4m in diameter. Manual removal of these plants takes dedication, as fragmented root systems will simply resprout and aid in spreading the weed further if not disposed of properly. The long vine-like stems of this weed will choke out surrounding plants by wrapping their vines around other species stems counterclockwise until enveloped. Field bindweed will also outcompete native species for water, nutrients, and light. This species is highly resilient to droughts and the prolific vines can clog up farming or maintenance equipment, even damaging equipment in some cases.

Origin: This invasive originated in Eurasia.

Control Options:

Prevention

- Reseed all areas where ground disturbance has occurred and minimize ground disturbance near invasive weeds.
- Remove seeds from gear, equipment, or vehicles before leaving a site. Clear Livestock of seed or plant fragments before changing pastures.
- <u>Do not compost</u> this plant, as root and stem fragments can continue to grow and resprout after being
- Avoid tilling or digging near this weed as fragmented pieces can sprout into a new plant.

Mechanical Control

- Hand-pull small infestations, ensure the entire root system is removed.
- Goats are able to eat this invasive and repeated grazing can help hinder seed production and deplete root reserves.
- Mowing is not recommended, it is likely to fragment the vines, further spreading the weed and also may damage equipment.

Chemical Control

- "Herbicide can be painted or brushed on bindweed leaves.
- It is recommended to use glyphosate on bindweed.
- Please carefully read and follow herbicide labels prior to application."
- Fraser Valley Invasive Species Society

Disclaimer - ALL herbicide applications must be applied as spot spraying; broadcast spraying may negatively impact other vegetation in the area & harm sensitive ecosystems.

Herbicide application within 5m of a body of water (seasonal or not) is prohibited.

LNIB requesting that the application of herbicide to treat half an acre or more, is carried out by a person holding a valid BC Pesticide Applicator Certificate. Before selecting and applying herbicides, you must review and follow herbicide labels and application rates; municipal, regional, provincial, and federal laws and regulations; species-specific treatment recommendations, and site-specific goals and objectives.

HOUSING ANNOUNCEMENT

SEPTIC SYSTEM MAINTENANCE

Your septic system is a living ecosystem, and you need to do your part to ensure it is healthy and working as it should.

Never put anything down the drain or toilet that will not biodegrade, including but not limited to, wipes (Lysol, baby, etc.), clothes, bottles, feminism products, paper towel, plastic, etc.

Don't use chemicals like bleach as it kills the good bacteria that breakdown the solid waste.

Space out your water consumption so the tank and drain field are not overwhelmed. By this we mean don't do excessive loads of laundry in a day, have extended showers, leave your tap running unnecessarily, etc.

The drain field (or leach field) is the area on your property where wastewater from your septic system is dispersed into the soil. To avoid damaging the drain field and overall functioning of the septic system; - Never park a vehicle, build a structure, have large livestock animals, have fires, or plant trees or a garden over your septic system's drain field - You should also prevent excess water from flowing over your drain field by making sure your downspouts are pointing away from it because a saturated field cannot drain and process wastewater.

These are some of the simple steps that can save time and money and extend the life of your septic system.

On December 6, 2023, at Shulus Hall, history was made as LNIB Economic Development hosted the inaugural Bear's Den Business Pitch Competition! This event took months of planning, coordination and most importantly, the courage of participants to develop their pitch and communicate it with the group. There were about 40 people in the audience and the event was catered by Kekuli Café.

The evening started with a short presentation by Adam Ova, Economic Development Project Manager about business planning and things to consider when applying for financing for a small business.

Following this, the pitches were made in order from Adelphi Grappling, Equine Therapeutic Development Programming and Six Mile Wood creations.

Adelphi Grappling

Adelphi Grappling is a Jiu-Jitsu gym location in Merritt, BC. Ashleigh Huston, LNIB Band member and her spouse Scott Dawson are interested in purchasing an interest in the gym that is currently run by Matt Wycotte from the Williams Lake Indian Band and his son Kasey Wycotte from the Coldwater Indian Band. The presentation was delivered by Ashleigh's mother Barb Huston who delivered an energetic pitch to the audience.

Adelphi just started their business and in the first two months, attracted 25 people to the gym and sent a team to Burnaby to compete in a Jiu-Jitsu competition, earning them a placement of 21 out of 63 teams, taking home a gold and two silver medals.

Adelphi aims to continue their growth by offering affordable membership costs and a venue for other types of fitness and conditioning.

Equine Therapeutic Development Programming

Equine Therapeutic Development Programming is an enterprise seeking to provide low-cost equine development services that provide a blend of therapeutic and recreational benefits to people seeking relief from trauma and an outlet for their time. Entrepreneur Phil Dumont has a vision where people can access horses for a low cost and be able to connect with them. Phil delivered an emotional and enthusiastic presentation for his many supporters that proved to inspire many people in the room. Phil would also like to shoutout Vanessa Buoanno, Youth Worker with the Health Department, on developing his pitch and giving him the confidence to present.

Phil has currently been offering these services with Family services subsidizing fees for participants. Phil would like to grow this program and expand the offerings to the public in the new year.

To decide the winner, LNIB Accounting Manager Michael Jackson and Adam Ova scored each pitch on a criterion, and it was decided that Equine Therapeutic Development Programming was the winner of the \$2,000 prize. Phil is using the funds to further develop his programming and establish a business that may be in the form of a non-profit or social enterprise.





The bite of the wind on your cheeks, the crisp feeling of inhaling winter air, and the peaceful sounds of soft snow falling from the sky. Winter is a season of senses, and for the Indigenous peoples, it is a season of hidden gifts and unique experiences for the heart and spirit.

Grab your scarf and a warm set of mittens, winter is a season to experience firsthand. People for thousands of years have lived in harmony with the land and its seasons, so should we. Within each of the vibrant cultures of the N'lakapamux people come traditions and a deep history with the seasons. There are many lessons, beauty, and wisdom to discover outdoors in the depth of winter.

Winter is a season of subtlety. A contrast to the explosion of life and colour in the summer, winter is the calm and restfulness that is just as important. The land is a bounty of gifts and wisdom that takes patience and respect to know where to look.

"To understand that winter lays asleep on the land and offers sleep to the land, it is regenerative," said Brenda Holder as she reflected on the necessity of the season. Taking time to rest and regenerate is not just something that is essential for the land but restfulness and reflection are just as important in our own lives.

Quilts of snow tuck in the land for rest, and while there is a surface appearance of a land that is withholding its life until spring, that is far from the truth. Winter is alive with medicines and lessons that have been passed down for generations. These medicines come in many forms, and some only available in the depths of winter.

Copes of birch, poplar, and spruce trees, while dormant, are not without their medicines to give to those in tune with all of their senses. Winter is not just the feeling of cold on your nose or the wind on your skin, but the subtle smells and noises that can be missed in the bouquet of summer and spring.

"There was a dual nature of winter, seeing it as such hardship and seeing it as such a beautiful wonderland that created so many gifts for us. " ~ Brenda Holder

So, take a moment to walk through a forest or meadow this winter. Listen and watch for the abundance of gifts that around you that the land provides. Our N'lkapamux territory is home to some of the worlds most stunning winter landscapes and experiences for those willing to take the step out into the snow. A winter wonderland waiting to be explored.

Lower Nicola Indian Band License Approvals

Lower Nicola Indian Band has harvest rights for 87,258m³/ year from:

- Two Replaceable Forest Licenses
- One Non-Replaceable Forest License
- Woodlot License

So far, there have been four cutting permits approved in the Pike/Dillard area, containing 37 cutblocks and totaling 136,883m³.

Additionally, a cutting permit was approved on the Woodlot for another 4,600m³.




Jpdated riparian standards include increased reserve widths and increased management zones.

Within these cutting permits, many cultural values are being managed for including Mule Deer Winter Range, Old Growth, water quality, biodiversity, wildlife habitat, and invasive plant species.

With input from the LNIB Natural Resource department Weyerhaeuser has increased riparian protection, retention in blocks and staff awareness towards cultural resources and features.

Helping neighbors goes both ways. SFE has been able to utilize an available excavator to assist USIB with rehabilitation of their temporary roads as well as with water control on their site!


Future Plans

Shulus Community Garden, December 2023

Greetings from Shulus Community Garden! Since there isn't a whole lot to do down at the garden we have decided to experiment on our herbs. Growing them over winter under grow lights and propagating. (Propagate means to cut a part of the plant to make more.) for example Kat Peterson has cut afew branches off from a rosemary plant, stuck it into some water and in about a week, roots were starting to show. After roots start to show, this indicates that its ready to be planted into soil. We chose rosemary to propagate because rosemary is a picky plant to get started. We hope to experiment with growing other herbs this winter such as oregano for example.

November Activities:

- Dehydrated tomatoes
- Dehydrating garlic to make garlic powder.
- Weekly watering of herbs
- Feed and water worms
- Collect worm juice for fertilizer.
- Clean honey extractor & put away.
- Clean wet honey frames for springtime feeding.
- Treat Bees with a liquid miticide with the help of Kent Miller.

Seeds collected this year:

- Tomato
- Marigolds
- Asparagus
- Pumpkin
- Pepper

Harvest Station:

Thank you, Farm Credit Canada, for granting Shulus Community Garden funds to renovate rebuild our old Harvest Station. We are just in the completion phase by adding doors and additional drainage profile. We are waiting for the signage from Farm Credit Canada and then we will host a ribbon cutting ceremony.

Shulus Garden staff appreciated the opportunity to provide you with fresh produce and Shulus Honey. We look forward to seeing again in the new year.


