

LOWER NICOLA INDIAN BAND

A BYLAW TO REPEAL THE WATER SYSTEM BYLAW (ENACTED AUGUST 18, 1971); THE BUILDING BYLAW (1979), NO. 1-1979; THE ADMINISTRATION AND MANAGEMENT BYLAW (1987) No. 1987-#1, THE EMERGENCY MEASURES BYLAW (1998) NO. 13, AND THE TRESPASS BY-LAW (2015) No. 2015-1

BYLAW NO. 2025-01

WHEREAS section 81(1), paragraphs (a), (d), (e), (h), (n), (p), (q) and (r) of the *Indian Act* empowers Lower Nicola Indian Band Chief and Council to pass by-laws to provide for to the health of residents on the reserve, the prevention of nuisances, the protection against and prevention of trespass by domestic animals, matters arising out of or ancillary to the powers under this section, and the imposition of a penalty for the violation of any such by-law;

AND WHEREAS Lower Nicola Indian Band Chief and Council did enact the Water System By-Law (1971) on the 18th day of August 1971, pursuant to the above noted authority;

AND WHEREAS Lower Nicola Indian Band Chief and Council did enact the Building By-Law (1979), No. 1-1979, on the 4th day of October 1979, pursuant to the above noted authority;

AND WHEREAS Lower Nicola Indian Band Chief and Council did enact the Administration and Management By-Law (1987), No. 1987-#1, on the 11th day of May 1987, pursuant to the above noted authority;

AND WHEREAS Lower Nicola Indian Band Chief and Council did enact the Emergency Measures By-Law (1998), No. 10, on the 19th day of January 1998, pursuant to the above noted authority;

AND WHEREAS Lower Nicola Indian Band Chief and Council did enact the Trespass By-Law (2015), No. 2015-01, on the 3rd day of February 2015, pursuant to the above noted authority; and

AND WHEREAS Lower Nicola Indian Band Chief and Council is of the opinion that such by-laws are not required at this time.

NOW THEREFORE Lower Nicola Indian Band Chief and Council enacts a by-law as follows:

1. The Water System By-Law (1971), enacted on the 18th day of August 1971, is hereby repealed.
2. The Building By-Law (1979), No. 1-1979, enacted on the 4th day of October 1979, is hereby repealed.
3. The Administration and Management By-Law (1987), No. 1987-#1, enacted on the 11th day of May 1987, is hereby repealed.
4. The Emergency Measures By-Law (1998), No. 10, enacted on the 19th day of January 1998, is hereby repealed.

5. The Trespass By-Law (2015), No. 2015-01, enacted on the 3rd day of February 2015, is hereby repealed.

THIS BY-LAW IS HEREBY ENACTED at a duly convened meeting of the Lower Nicola Indian Band Chief and Council at this 1st date of April 2025.


